- Applicant is a qualified done;
- Demonstrates capacity to deliver the project;
- Responds to current Vital Signs report;
- Implemented within and impacts Foundation's catchment;
- Contributes to systems/long-term-change;



### **Eligibility Criteria (Continued)**

- Involves contributions, monetary or other, from other sources;
- May involve collaboration / strategic partnerships;
- Request is a minimum of \$50,000 over a one, two, or three year period; and
- All expenditures are eligible according to the program criteria.

#### **Evaluation Criteria**



#### Proposals will be evaluated based on:

- Is it substantively new
- Proposes significant change to the current state of affairs
- Is innovative while still accountable and measurable
- Improves, or leverages resources/investments to increase impact
- Acts on the concept of "nothing about us, without us;" and
- Strength of collaboration/partnerships where applicable

#### **Collaboration Success Factors**



- Shared understanding of the issue/perspectives and goals
- Willingness/commitment to participate
- Roles and responsibilities
- Mutual benefits/buy-in
- Trusted relationships/Shared values
- Governance arrangements
- Agreement/Memorandum of Understanding established

### **Potential Negative Outcomes**



- Power and control imbalances and resulting issues
- Mistrust
- Sense of lost identity
- Different and conflicting visions
- Different expectations of outcomes
- Conflict about working styles





#### Proposals will be evaluated with the following in mind:

- Collective understanding of the issue;
- Detailed understanding of roles;
- Agreement of allocation/resource of funding;
- The right skills, knowledge, behaviours, and support structures in place; and
- Senior leadership commitment and support.

#### **Three Review Stages**

- 1. TODAY'S FOCUS Letter of Intent (LOI) deadline January 23 @ 2PM EST..
- 2. Application Those selected from the LOI review will be invited to complete the in-depth application online by March 26.
- 3. Interview Applications will be reviewed and those selected will be invited to an interview with the grants committee to present their project May 23. Supported proposals will receive funding in the fall based on a Memorandum of Understanding.



#### LETTER OF INTENT (LOI)

LOI must be only two pages and explain the proposal in narrative form with all of the following details:

- Project details and Vital Sign issue area
- How it will benefit the community
- How it will be carried out
- Who will be involved and what are their roles; 'nothing about us.
   without us'
- Capacity of proponents
- High-level budget and funding needs and how LCF's funding will be allocated; what other resources will be accessed
